Any Contractor registered with the Central Government / any State Government or any PSU or an agency of international or national repute may participate in the tender but registration with the Road Construction Department, Bihar will be essential after issue of L.O.A. and before executing the agreement.

13. For participating in the above E-Tendering process, the contractors shall have to get themselves registered with the service provider so that user ID, password and Digital Signature are issued to them. This will enable them to access the website www.eproc2.bihar.gov.in and download/participate in E-Tender. 14. The undersigned reserves the right to extend or cancel or reject the tender/tenders at any time without assigning any reason thereof. No cost what so ever shall be claimed on such account by the bidder.
15. Earnest money (Sr. No. 8 Column 4) can be only in the form of Bank Guarantee duly endorsed/pledged to Executive Engineer, RCD, Road Division, Sherghati. (**Reference - Engineer in Chief, RCD, Bihar Patna Letter no – 5651(E), dated – 19.08.2020.**)
Bank Guarantee should be unconditional in the prescribed format of SBD issued from any Nationalized/ Scheduled Bank and it should be valid for the minimum period of 165 days after last date of uploading of tender.
Earnest money can also be paid through e-payment mode i.e. “Internet payment gateway, Credit/Debit card, Net banking, NEFT/RTGS”
16. Cost of BOQ/Bid processing fee as per Sr. No. 8 column 5 & 6 of is mandatory to be paid through online mode i.e., internet payment gateway (credit card/debit card) Net Banking / NEFT/RTGS through e-procurement portal www.eproc2.bihar.gov.in before the date and time specified in the NIT. The department does not take any responsibility for the delay/non submission of tender/non reconciliation of online payment caused due to none availability of internet connection, network traffic/holidays or any other reason. Scanned Copy of receipt should be uploaded along with tender document.
17. As per RCD Letter No 971 (E) we dated 10/02/2021, along with tender document it is mandatory for tenderers to upload their valid character certificate.
18. Bidders/ Contractors can access tender documents on the website and must fill them and submit the completed tender documents in electronic form on the website itself. Bidders/ Contractors shall attach scanned copies of all required papers, B.G. and certificates as required in the eligibility criteria. All the uploaded documents shall have the signature of bidder or their authorized signatories. The scanned copies should be of the original papers and certificates.
19. In compliance to RCD letter no. 3987(s) dated 28.04.12 and 3407(s) dated 18.3.11 an Affidavit in the format must be attached within the bid document.
20. Before uploading tenders, bidders are advised to go through the SBD uploaded with the tender document.
21. Contractor will have to deposit additional performance guarantee for seriously unbalanced rate quoted by him at the time of agreement as per RCD letter No.447 (S) dated 16-01-2020.
22. Bids from joint ventures are allowed as per the eligibility criteria and other instructions issued by Road Construction Department, Bihar. This is available on department website.
23. The bidders are requested to check their file size of uploaded documents at the time of submission & they should ensure that work file is uploaded. If they feel that the complete file is not uploaded then they should click on cancel & update the same before submission. The bidders should satisfy themselves of Download ability/visibility of the scanned & uploaded file by them.
24. As per Departmental **letter no. 3987(s), dated 28.04.2012**, bidders will have to declare by affidavit that they have not been declared defaulter or blacklisted by any State Government/ Central Government/Public Undertaking. If such affidavit is subsequently found to be false, their tender shall not be considered and further legal action shall be initiated.
25. It is mandatory for bidders to upload an affidavit to the effect that they are not ineligible to participate in the tender [**ref: RCD letter no. 3407(s), dated-8.03.2011**]
26. The bidders are directed to zip their files using WinZip or WinRAR software only. Other formats of zipping will not be accepted and will be rejected.
27. In the unlikely event of the server for eproc2.bihar.gov.in being down for more than two consecutive hours (in the period from midnight to closing time for receipt of tenders) on the last date of receiving of bid, the last date of the same shall automatically be extended to next working day till the last receiving time stipulated in the original NIT.
28. There is no ceiling/limit for going below the BOQ rate for percentage rate tenders as per departmental letter no 447(S) and 449 (S) dt-16-01-2020 & 4439 (E) dt. 17-07-2023 but will have to deposit additional Performance Guarantee needed as per direction.
29. The bidder must use MS Office-2007 or lower version. File size should be less than 5MB and should be in Ms Word, Ms Excel, PDF and JPEG formats.,
30. “Bids along with necessary online payments must be submitted through e-Procurement portal eproc2.bihar.gov.in before the date and time specified in the NIT. The department doesn't take any responsibility for the delay/Non Submission of Tender/Non Reconciliation of online Payment caused due to Non-availability of Internet Connection, Network Traffic/Holidays or any other reason. No claim shall be entertained on account of disruption of internet service used by bidders. Bidders are advised to upload their bids well in advance to avoid last minute technical snags.”

As per Departmental letter no. 7435(S), Dt. 14.08.2019, "In exercise of the powers conferred under Article 166 (3) of the constitution of India, the Governor of Bihar is pleased to substitute Contract Clause 25 of State SBD (Standard Bidding Document) by the following with effect from the date of its publication in the official gazette" -
"Contract Clause-25 Settlement of Disputes and Arbitration" -
 "The Settlement of Disputes and Arbitration shall be done in accordance with the provisions made in Bihar Public Works contracts Disputes Arbitration Tribunal Act, 2008."
33. Affidavit Must be on paper stamped with Adhiwakta Kalyan Kosh Stamp of Rs 25/- (vide Lt No. 3608 (E) dt. 22-05-2020
34. The power of attorney must be on Rs. 1,000.00 (one thousand rupees only) Paper stamped with Adhiwakta Kalyan Kosh Stamp of 25 vide office of the Registrar Patna. Letter No.- 212 dt. 30-01-2024 and Department of Registration, Excise & Prohibition Letter No. - 1026 dt.- 15-02-2013
35. As per Additional Chief Secretary, Home Department, Bihar, Patna Lt. No. 29, Dt. 25-01-2021 and R.C.D., Bihar Department Letter No.-2033 (E) Dt. 11-04-2022. It is mandatory to submit character certificate before agreement.
36. As per Departmental O.O No.- 07, Dated 10-01-2024 and Memo no.-163(E), Dated 10-01-2024, all documents related to tender will be acceptable only online.
37. As per RCD Letter No. 7930 (E) dt. 26/11/2025 bidder submit existing commitment of ongoing works countersigned by concerned Executive Engineer.
38. As per RCD Lt. No.-2955 (s) we dt. -07-04-2025 successful Bidder must have to register and use CBuD App.
39. Corrigendum/ Addendum, if any, will be published on the website itself.
