Request for Proposal (RFP) for Consultancy Services for Preparation of Detailed Project Report (DPR) and Transaction Advisor (TA)

Bihar State Road Development Corporation Ltd. Patna (A Government of Bihar Undertaking) has been entrusted for availing consulting services for preparation of DPR and Transaction Advisor (TA) for the proposed Buxar – Bhagalpur Six-Lane Greenfield Access-Controlled Expressway.

Accordingly, BSRDCL intends to procure Consultancy Services for the preparation of DPR & Transaction Advisory Consultants for the following proposed Road/Bridge/elevated Road projects: -

2. RFP is invited from eligible Consultancy Firms (registered and incorporated in India) for availing the services of DPR Consultant and Transaction Advisor on the basis of-Open Competitive Bidding. The selection of the DPR Consultants and Transaction Advisor would be on QCBS Basis with 70:30 weightage for Technical and Financial Scores respectively.
3. The proposal shall be submitted in English Language and all correspondence would be in the same language.
4. The selection of Consultants shall follow the laid down procedures given in the RFP Document.
5. The interested consultancy firms may download the RFP document from the e-tendering Portal of Govt. of Bihar (eproc2.bihar.gov.in) w.e.f. the scheduled date and time as mentioned in critical data sheet. The Consultant who downloads the RFP document from the website will be required to pay the non-refundable fee of Rs. 11,800/- at the time of the submission of the proposal for each project, payable online through the eProc2 online

payment gateway. The RFP will be invited through e-tendering portal "eproc2.bihar.gov.in". The BSRDCL invites proposals through e-tendering Portal of Govt. of Bihar i.e. eproc2.bihar.gov.in (on-line Technical as well as Financial Proposal submission by using the portal). The complete RFP document can be viewed / downloaded from eproc2.bihar.gov.in and can also be viewed on official portal of BSRDCL <http://bsrdcl.bihar.gov.in> as per schedule given in Critical Data Sheet as under: -

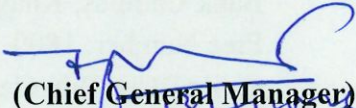

The interested Consultancy Firms who have experience in preparation of DPR with Transaction Advisory experience for Roads and Bridges/ Elevated structure and fulfilling technical and financial criteria as specified in RFP may obtain Request for Proposal (RFP) document from – www.eproc2.bihar.gov.in only.

7. The Applicant shall furnish as part of its Proposal, a Bid Security in the favour of Chief General Manager, Bihar State Road Development Corporation Ltd. Patna for an amount of Rs.10,00,000.00 (One Lakh Only) either online or through Bank Guarantee from any Nationalized Bank and shall remain valid till 28 days beyond the Bid validity period of 120 days. Bid Security in Original form (or, payment receipt of Bid Security in case of online payment) will have to be deposited along with Hard Bound Copy of Technical Proposal only in the office of Chief General Manager, Bihar State Road Development Corporation Ltd. Patna on or before the time and date specified above and mentioned in Data Sheet, failing which the Proposal will be rejected.
8. E-tendering processing fee, as applicable shall be paid online to BELTRON at the time of uploading of RFP.
9. For participating in E-RFP process, the applicant shall have to get them registered to get user ID Password and digital Signature. This will enable them to access the website- eproc2.bihar.gov.in and participate in e-tender. Those who are not registered in e-tendering systems, they may contact : mjunction services limited, RJ Complex, 2nd Floor, Canara Bank Campus, Khajpura, Ashiana Road, P.S. - Shastri Nagar, Patna 800 014, Bihar (Toll Free Number: 1800 572 6571). The bidders must have bid encryption through pass phrase as per RCD, Bihar letter no : -5651(E), dated-19.08.2020.
10. The blank RFP documents can be downloaded from the website- eproc2.bihar.gov.in, where electronic RFP form is provided.
11. Consultants can access RFP documents on the website, fill them and submit the completed RFP document into Electronic RFP on the website itself. Consultants shall attach scanned copies (PDF/JPG) of all the required RFP papers, Bank Draft, Bank Guarantee, & the certificates as required in Eligibility criteria.
12. All the uploaded documents shall have the signature of consultants or their authorized signatories. The scanned copies should be of the original papers and certificates.
13. The Consultant is requested to check their file size of uploaded documents at the time of submission & they should ensure that work file is uploaded if they feel that the complete file is not uploaded then they should click on cancel & update the same before submission. The Consultant should satisfy themselves of Download ability and visibility of the scanned & uploaded file by them.
14. The Consultant is directed to zip their files using Win Zip or Win RAR software only. Other formats of zipping will not be accepted and will be rejected.
15. The Consultant must use MS Office-2007 or higher version.
16. No claim shall be entertained on account of disruption of internet service being used by Consultants. Consultants are advised to upload their bids well in advance to avoid last minute technical snag.

As per Department Letter No. – 3987 (s) dated- 28.04.2012, tenderers will have to declare by affidavit that they have not been declared defaulter or blacklisted by any state Government/Central Government/Public undertaking. If such affidavit found to be false, their tender shall not be considered and further legal action shall be initiated.
19. As per order of Principal Secretary, RCD, Bihar, Patna vide letter No. 4109 (S) Dt. 04.06.2018, if Bid Security is found invalid in verification the tenderers will be black listed.
20. The BSRDC Ltd. reserves the right to extend /cancel the tender (RFP), either for all Projects or any of the Projects, at any stage without assigning any reason.
