10. Any Contractor registered in appropriate class with Central Government/ State Government or their undertakings, any PSU in requisite class, or an agency of international or national repute may participate in the tender but registration with the Public Health Engineering Department, Bihar in requisite class will be essential after issue of LoA and before signing the agreement.
11. The bidder shall submit his bid/tender on e-Procurement platform at www.eproc2.bihar.gov.in.
12. The bidder must have the class I/II Digital Signature Certificate (DSC) with signing+ Encryption and user-id of the e-Procurement website before participating in the e-tendering process. The bidder may use their DSC if they already have. They can also take DSC from any of authorized agencies. For user-id they have to get registered themselves on e-procurement website www.eproc2.bihar.gov.in and submit their bids online on the same. The offline bids shall not be entertained by the tender inviting authority for the tenders published in e-procurement platform.
13. The bidders shall submit their eligibility and qualification details, technical bid, financial bid etc, in the online standard formats given in e-procurement website at the respective stage only. The bidders shall upload the scanned copies of all the relevant certificates, documents etc, in support of their eligibility criteria/technical bids and other certificates/ documents in the e-procurement website. The bidder shall digitally sign on the supporting statements, documents, certificates uploaded by him, owing responsibility for their correctness/authenticity. The bidder shall attach all the required documents for the specific tender after uploading the same during the bid submission as per the tender notice and bid document.
14. All the required documents should be attached at the proper place as mentioned in the e-forms otherwise the tender of the bidder will be rejected.
15. Tender Processing Fee (TPF) to be paid through e-payment mode (i.e. NEFT/RTGS, Credit/Debit Card and Net Banking) only.
16. The cost of the BOQ/form fee to be paid through e-payment mode (i.e. NEFT/RTGS, Credit/Debit Card and Net Banking) only.
17. "Earnest Money Deposit" (EMD) can be paid either through e-payment or manual mode (BG,DDetc).In case of manual mode of payment of the EMD, the original hard copy of the EMD which may be in DD/BG or any other instrument that should be

submitted in the tendering authority office within the next working day after the tender closing date."

Note: "Bids along with necessary online payments must be submitted through e-procurement portal www.eproc.bihar.gov.in before the date and time specified in the NIT. The department/tendering authority will not take any responsibility for the delay/non submission of tender/ non reconciliation of online payment caused due to non-availability of internet connection, internet traffic/holiday or any other reason."

18. The tender opening will be done online on www.eproc2.bihar.gov.in only.
19. Any corrigendum or date extension notice will be given on the e-procurement website only.
20. **Bidder must qualify following eligibility criteria:-**

(i) Achieved in any one year during the last five years, a minimum annual financial turn over (in all classes of civil engineering construction works) volume of construction work of at least the amount equal to 5%(five percent) of the estimated cost of the works for which bid has been invited. The turnover will be indexed at the rate of 8% for a year.

OR

New bidders registered I having applied for registration with Govt. Department and having financial capability but no prior turn over but willing to bid, shall be eligible to participate in the tender provided an additional Bank Guarantee to the tune of 2% of estimated cost of the works for which bid has been invited and having validity till the period of work completion duly pledged is submitted with the technical bid of the tender.

The additional Bank Guarantee as required above is in addition to mandatory deposits as per bid documents/ conditions for participating in the tender.

(ii) "Satisfactorily completed civil engineering construction work of value not less than 5 % (Five percent) of estimated value of work in any one year during last five financial years."

OR

New bidders registered / having applied for registration with Govt. Department and having financial capability but no prior work experience but willing to bid, shall be eligible to participate in the tender provided the conditions regarding additional Bank Guarantee of 2 % of Estimated cost will be submitted.

21. Earnest Money should be in shape of 1year/ 2 years/ 3 years TD; issued within the State or as per Bihar Financial Rules duly pledged in favour of Executive Engineer, PH Division, Araria or Bank Guarantee issued from any Schedule Bank within state (If issued from any bank outside state then it will be converted to any bank within state before executing the work agreement) and valid up to 225 days after the date of receipt of tender.
22. Detailed terms and conditions of tender will be enclosed along with the Bidding Document, and will be binding on the tenderer.
23. The bidders must submit an affidavit separately with the bid document that they are not liable for disqualification as per clause 4.8 (Instruction to bidders: Section 1 General) of the Bid Document.
24. For rates quoted below the estimated cost, additional performance guarantee shall be deposited by the tenderer as per conditions of bid document and government circulars at the time of agreement.
25. The bidders are advised to visit work sites before submission of tender to study local conditions, availability of labor and material etc.
26. The undersigned has the right to extend, accept or reject the tender without assigning any reason thereof.
27. The estimated cost may increase/decrease, though cost of tender document, bid processing fee and amount of earnest money will remain the same.

28. No claim shall be entertained because of disruption of internet service being used by the bidders. Bidders are advised to upload their bids well in advance to avoid last minute technical snags.
29. **In pursuance of the judgment of Honl' High Court in CWJC no. 9941/2022 and relevant office orders of RCD vide letter no. 447(s), 448(s) dtd. 16.01.2020 and BCD letter no. 556(Bh) dtd. 17.01.2022 the clauses of these letter shall be admissible for this tender.**
